4. The grant will support a service or program directly provided by your organization, **not a pass-through (you get the funds and give them to another organization)**. This grant may also support equipment, operating, administrative or capacity building expenses.

5. The grant will not be used for a structural or capital campaign, fundraising event, celebration function, or private event.
6. If you have received a grant from the Community Foundation, **you have completed all required grant reports and are in good standing.**
7. The project will be **completed by September 30, 2026.**
